The Intersection of High Tech and High Touch

Who?

Sixteen Extension professionals (Core Facilitation Team) participated in ten days of focused training by attending four separate sessions. These sessions were conducted by Extension Organizational Development.

One hundred and ten Extension professionals participated in three days of focused training provided by the Core Facilitation Team.

What?

The core facilitation team received focused training on topics including the fundamentals of facilitation and process management, multi-party facilitation, large group process design and strategies, and strategic planning.

The district trainings covered process management, group dynamics, core values, facilitator roles, agenda basics, facilitator tool introduction, conflict management, & hands-on practice/role plays.



Why?

The NC Facilitation program was designed to 1) build the capacity of a core team by developing their facilitative behaviors and skills, and expertise in meeting management and public issue facilitation, 2) continue to develop their capacity through advanced training in facilitation, and 3) provide multidisciplinary statewide essentials in facilitation training while mentoring more novice facilitators in local, regional, and statewide projects.

So What?

Results of the NC Facilitation Program:

- Substantial economic impacts by saving both county and state resources
- Social impacts, in strengthening working relationships between Cooperative Extension within counties, across districts, and between counties and campus.
- Extension is viewed as conveners and managers of process


